TUITION PAYMENT PROCESS



All families (regardless of payment plan selected) are **required** to maintain an active **FACTS Tuition Management** account for tuition and fee payments. Please contact the Business Office with any questions or for assistance with enrollment.

PAYMENT OPTIONS

Monthly:

- Choose either a 10, 11, or 12-month payment plan (within the school year)
- All monthly tuition payments are processed via electronic funds transfer through FACTS Management

Bi-annual:

- Installments due August 10, 2026 and January 8, 2027

Annual:

- Due by August 10, 2026
- 3% discount applied to annual payment

PAYMENT POLICIES

The school strives to keep costs to parents as low as possible; therefore, prompt payment of all accounts is essential. Timely payments enable the school to meet its financial obligations.

Payments returned due to Insufficient Funds (NSF) will be reversed to the family's account. In addition to applicable late fees and finance charges, a \$30.00 NSF fee will be assessed for each returned payment.

The school reserves the right to dismiss any student whose financial obligations remain unpaid 30 days after the due date. Student records and transcripts will not be released until all outstanding balances are paid in full. If a pattern of late payments requires frequent reminders, the school may require advance payment by semester as a condition for re-enrollment for the following academic year.

If a student withdraws before the completion of the school year, the family remains responsible for all tuition and fees through the end of the month of withdrawal, calculated on a standard 10-month payment plan.

Any account with a past-due balance as of February 23, 2026, will lose priority for re-admission, with preference given to new applicants. Additionally, no student whose parent or guardian has an outstanding tuition balance will be re-admitted for the following academic year unless the balance is paid in full by June 30, 2027.

Senior accounts must be paid in full by May 15, 2027, in order to receive a diploma at graduation.
